

How to make a request for information from the ERA

Please review the *ERA Publication Scheme* document on the Freedom of Information webpage (http://www.caymanera.ky/freedom-of-information) to determine whether or not the Electricity Regulatory Authority (ERA) holds the information you are seeking. You may also direct any questions you may have to the ERA Information Manager by email at foi.era@gov.ky or by telephone at 1 (345) 949-8372.

If the ERA retains the information you seek, you must submit a request in writing (i.e. letter, e-mail or on the Freedom of Information Law 2007 Application Form¹) to gain access to that information. Written requests should be specific about which information you are requesting, as this will ensure a prompt response. Please include a daytime telephone number so that you can be contacted to clarify your request (if necessary).

In your written request you will need to state the following:

- 1) Your detailed request for information;
- 2) Whether you wish to inspect or view the information or records; or
- 3) The format in which you wish to receive the information requested (e.g. photocopy, compact disc, transcript); and
- 4) The number of copies required for each record
